

Dr. John Mascia is the Alabama Institute for Deaf and Blind's 17th President. He holds bachelor's and master's degrees in audiology and speech pathology from Hofstra University in New York and has a doctorate in audiology from the Pennsylvania College of Optometry, School of Audiology. He received his certificate of clinical competence in audiology from the American Speech-Language-Hearing Association and is a licensed audiologist. He has made numerous presentations and served in leadership roles with professional organizations and is widely published. Dr. Mascia has worked as a supervising and chief audiologist and as an assistant professor in New York. In 1989, he joined the Helen Keller National Center, where he served as coordinator of Audiological Services, supervisor of the Speech and Hearing Department, coordinator of Professional Services and then finally as national director of Field Services. As a senior administrator, he was responsible for the supervision of regional representatives, national training programs, community placement services, and 45 affiliate programs. In 2005, he joined AIDB as executive director of the E.H. Gentry Facility and Regional Centers and was promoted to the role of vice president of Adult Programs in 2009. On January 1, 2013, he became President of AIDB.

He serves on numerous boards and community organizations including the American Speech & Hearing Association (ASHA) Board of Ethics; Hearing Charities of America; Talladega College Board of Trustees; International Motor Sports Hall of Fame Board of Directors; Lions Club International–Talladega; Talladega Red Door Kitchen; Leadership Alabama; Easter Seals-Talladega Chapter, and numerous advisory councils.

Dr. Mascia is married to Nancy Mascia, and has three children, Chris, Katie, and Annie.

She currently works in three school systems in Alabama helping blind/low vision students from kindergarten through high school learn the skills for academic and personal success. Chantal is also a part-time vendor for ADRS (Alabama Department of Rehabilitation Services). As an O&M vendor for the State of Alabama, Chantal works with students that have graduated from high school and are in need of O&M on the college campus that they will attend. Volunteer Projects: Chantal is an active member of the National Federation of the Blind (NFB). She has volunteered at all of the NFB Youth Slams. This a national event that engages blind high school youth in activities that promote careers in science, technology, engineering, and math. -Chantal is the past President of the Alabama Association for Parents of Children with Visual Impairments (AAPVI). She has been affiliated with the group for 12 years. -Chantal also volunteers for events hosted by the UAB Center for Low Vision Rehabilitation, Songs for Sight, Support Group. She collaborates with Songs for Sight annually to host the Children's Harbor Weekend Family Camp Experience for families with children who are blind or have low vision. -In 2018 Chantal volunteered to participate in College Quest on the campus of Auburn University. She provided O&M to students with visual disabilities that were selected to attend this program. The purpose of College Quest is to teach high school students with

visual impairments how to use the tools that will promote success in college.

that have stolen her heart. Elizabeth enjoys college football and spending time with family and friends.




#### ESTELLA BEAVERS

He was appointed to the United States Military Academy (West Point) in 1982 and was scheduled to report to Cadet Basic Training, but was injured June 27, 1982 in a head-on motor vehicle collision with a drunk driver, which left him with a closed head injury and permanent paralysis from the waist down and a full time wheelchair user.

In January 1983, Dr. Sisson entered the University of North Alabama. He was graduated summa cum laude in 1987 with B.S. in Accounting and minors in English and History. He received the Keller Key (highest GPA) and Turris Fidelis(highest award to graduating senior) keys upon his graduation. In his senior year, he was elected SGA President.

After his graduation from UNA, Dr. Sisson attended Vanderbilt Law School and was graduated in 1990 with a JD and licensed in September 1990. Prior to being appointed a deputy attorney general and an assistant attorney general with the State of Alabama, Dr. Sisson worked for several Birmingham law firms. He now serves as the State's ADA Coordinator and Assistant Attorney General with the Alabama Department of Rehabilitation Services. He was reappointed by Governor Kay Ivey as the Director of the Governor's Office on Disability and State ADA Coordinator. Dr. Sisson served as an adjunct law professor teaching a disability law course at the Birmingham School of Law and teaches a doctoral course in disability law and history at Auburn University. Dr. Sisson received his doctorate in rehabilitation from Auburn University in 2016.

He served 17 years as the Case Manager for Blind at the Huntsville Regional Center, until he was promoted in 2014 to Regional Director. Isaac has served on many boards and committees including: President of the Alumni and Workers Association of the Alabama School for the Blind (ASB Alumni), the State Rehabilitation Council, Blind Advisory Committee, Co-Chairman of the Huntsville Council on Accessibility, and serves as an Advisory Board Member for the Rehabilitation Counseling Program at Alabama A&M University. He is the creator and coordinator of 6 Transition Curricula for Blind and Visually Impaired students. Isaac has spoken at state, national and international conferences. In 2015 ASB Alumni awarded him the organizations highest honor, the Lillian Ricks Award. In 2016 Isaac was recognized by the Alabama Department of Rehabilitation Services (ADRS) Department of Blind Services for years of dedicated collaboration with the "Joined at the Hip" award. Isaac completed Leadership Huntsville Madison County in 2016, where he started the now annual Ability Career Fair for people with disabilities. Isaac has been married for more than 22 years and has two adult daughters and dog who thinks he is a person.

Jag Dawadi, MS, MAC, LPC-S, graduated from RIT with a bachelor's degree in Social Work in 1998. Upon graduation, he ventured out far north in Alaska where he worked for six years as an itinerant worker bringing mental health and addiction services to consumer's home communities, often flying with bush pilots.
